PRESIDENT'S REPORT

As the VRWC begins a new year of activity, it's clear that it does so during a time of sad history in the making. Only in wartime would sport, and other human pursuits, confront a period of such protracted social dislocation and upheaval, in which the only foreseeable certainty is uncertainty. In our Club's case, we've already seen the impact of this upon planning (short and long-term), competition, membership, finances and other aspects of club life. That said, the VRWC has earned a reputation for its adaptability and resourceful response to challenges. The events of 2021 saw the Club drawing upon these attributes once again in the face of a worsening yet unpredictable pandemic, and it is likely to be doing so for some time yet.

While the Winter program was COVID-affected, as it was in 2020, this time we were able to hold 11 of the 19 scheduled Winter race meetings. These included all but one of our AV, VMA and Club championship days, with strong results in all. Competitors saw our Olympians (**Rhydian Cowley, Jemima Montag, Kyle Swan** and **Bec Henderson**) striding out ahead of them on the Middle Park course, pretty much up to their departure for Sapporo. What was disappointing was that, due to a reimposed lockdown in August, we were unable to welcome these four home and congratulate them in person on their performances in the oppressive heat of Sapporo. For the record:

- Rhydian Cowley (50km) 8th in 3h52m01s, in the last-ever Olympic 50km race.
- Jemima Montag (20km) 6th in 1h30m39s (first Olympics)

Jemima and Rhydian thus maintained Australian race walking's enviable record of having a medallist and/or top 10 placed finisher at every Olympics since 2000 – a record few other events can boast.

- Bec Henderson (20km) 38th in 1h38m21s (first Olympics ... youngest starter in the race)
- Kyle Swan (20km) 36th in 1h27m55s (first Olympics)

Four Olympic reps for a club of our size is a hallmark by any reckoning, especially for those of us who've watched their progression from underage Club racing to where they are now. We also commend their Sapporo team-mates, **Declan Tingay** (WA $- 17^{th}$ in 20km) and **Katie Hayward** (QLD $- 37^{th}$ in 20km) on their gutsy efforts. Congratulations, team!

In June, we took delight in seeing VRWC legend **Harry Summers** rewarded for his years of service to the sport of athletics with an Order of Australia medal ... the third to be awarded to a member of our Club. Harry now joins Tim Erickson and Simon Baker as recipient of this accolade. Well done, H!

Off the course, we boosted our coffers a little at the Twilight Trivia evening. We saw a small but important increase in our membership. (Not to mention a shiny, new electric tricycle for easy course set-up and pack-up!)

A notable casualty of the August-October lockdown was the VRWC Centenary celebration, scheduled for September to coincide with the AA National 20km championship. Both, sadly, were cancelled. We are awaiting a firm date from AA for the 20km (after false starts in 2020 and 2021), and we hope to be able to conduct it alongside the Centenary event as planned.

For 10 years, it was the role of separate Victorian affiliate, Racewalking Victoria (RWV), to act as an umbrella organization under which the smaller regional walking clubs (Ballarat, Bendigo, Geelong) could participate in interstate events conducted by Racewalking Australia (RWA). As a

matter of unity, VRWC members also competed as RWV walkers for these events. This year, the VRWC applied to become the sole Victorian presence at RWA events, and Racewalking Victoria was wound up. Regional club members will compete as VRWC members at RWA competitions from 2022, again as a single entity but without the expense of maintaining a second organization.

In last year's report, I referred to a potentially rich recruiting field created by the lockdowns, one comprising people who had taken to walking as the only productive form of exercise at their disposal. An effort to harvest some of this crop was made through a poster campaign, with some success in the form of email enquiries to myself. More will be done in 2022, by this means and others, to bring the sport of racewalking – and our Club – to the notice of interested persons on the community.

The work started in 2021 to take stock of walks coaches and coach education in Victoria will resume. There are coaches active in Masters and Little Athletics centres, even if of an ad hoc nature, presently unknown to us. We aim to set up a database of such coaches, along with examining current coach training resources and ways of establishing a communication network through which coaches can assist each other and channel their athletes into the VRWC racing programs.

The saddest news the Club had to announce in 2021 was of **Peter Vysma's** catastrophic cycling mishap in October. The injuries Peter suffered are life-changing, and it is most unlikely that he will be able to return to his role as Judging coordinator nor even attend the Club in the foreseeable future. Happily, since the early diagnosis of quadriplegia, Peter has regained significant movement in his feet and hands and has now commenced a program of intensive rehab. Many Club and AV members have already sent him messages and he is now able to receive cards, flowers and gifts. His address is:

Peter Vysma – Royal Talbot Rehabilitation Centre, 1 Yarra Blvd, Kew 3101. He welcomes messages and greetings and would love hearing from his VRWC friends and associates.

Peter's loss to our judging panel is substantial and needs covering. We are always on the lookout for new judges. We urge non-racing (or casually racing) Club members, parents and supporters to consider training for this indispensable role. Please see me, Terry Swan or Diane Lowden if you are interested.

I would like to thank the many individuals who have given their time to perform the myriad tasks necessary to keep the Club's programs running: Terry Swan (Club secretary and race photographer); Mark Donahoo (race secretary, race director and handicapper); Karyn O'Neill (treasurer); Shane and Donna Dickson (new racing uniforms, hooded jackets and Club polo shirts); Peter Vysma (Judging coordinator); race judges Gordon Loughnan, Peter Price, David Cash, Michael Bodey, Kathleen Marsh, Diane Lowden, Brenda Felton, Shane Dickson, Terry O'Neill, Fran Attard and Ezo Uzun; Ralph Bennett (race entries portal); Committee members Heather Carr, Donna Elms, Madeleine Feain and Terry O'Neill; race day officials Donna Dickson, Bill Carr, Darlene Swan, Ian Laurie, Simon Baker and Tim Erickson – and the numerous members who've assisted with the setup and pack-away after each competition day, or helped in other small but important ways.

My thanks once again to Nate Zeeno and David Spokes of the Middle Park Bowling Club for their ongoing assistance, and to Neil Ryan of *Runners World*, for his sponsorship of our Summer awards at a time when maintaining the 'bottom line' has been a challenge for small businesses everywhere.

Finally, a special thanks and well done to Tim Erickson. Tim has at last stepped back to engage in his other interests after twenty years of up-front work in so many areas of Club activity. He has handed editorship of the Club newsletter 'Heel & Toe Online' to Stu Cooper and management of the 'Racewalk Australia' website to Kim Mottrom (SA).

Thanks, Tim. Good luck for the future. And a safe, healthy and successful year to all our members!

TREASURERS REPORT FINANCIAL YEAR - 1 October 2020 - 30 September 2021

The period of October 2020 to September 2021 was a better year than the last, for the Club as well as everyone in our community but still suffering from the effects of lockdowns. Due to reduced racing being possible due to COVID-19, the club has only just "broken even" recording a small profit of \$228.35.

Memberships were waived, although some were paid at the start of the year. Where possible, races were held, but no membership fees were requested.

The external event, (both for income and expense) was Lake Burley Griffin Carnival. The donations as listed are from members who were not able to participate at this event, and chose not to have their entry fees refunded.

New uniforms were purchased by the club last year as well as this year, but the club was not able to make them available until this year when racing was able to re-commence.

The Miscellaneous income was for the Trivia Night, ably organised by our President, and raffles organised by Donna Elms.

The Membership expenses listed are for membership of Race Walking Victoria.

There are a few items in the Miscellaneous Expenses, the main one was purchase of the eBike for use around the course during races – making life a lot easier for the volunteers, judging paddles and stop-watches, as well as flowers for deceased members. Also purchased (listed in Office supplies) were a laminator and printer.

The Club this year has made only a small profit, but the Club still has a sound financial base with which to move forward into the next year, to continue to provide members with the benefits of experience and camaraderie in a sport we all love.

I would also like to make mention that the Middle Park Bowling Club has not charged the club rental for this year, which has been very much appreciated.

I would like to thank all the committee members for their support. Separately, I would also like to thank Mark Donahoo, Heather and Bill Carr, Michael Bodey and the many others who have helped with taking the race entries and fees when able, also Terry and Stuart for helping me through the processes of the official side of the committee.

On a personal note, it was a shock to hear of Peter Vysma's accident and I am sure that all the members and committee send their best wishes for a speedy recovery, and recognition of all the work he put in for our club to be as successful as it is.
